Fall 2015 Statistics

During the fall of 2015, The Beaches of Fort Myers & Sanibel hosted about 1.1 million visitors who spent an estimated \$664 million while visiting – a 5.9 percent increase in spending yearover-year. Visitors staying in paid accommodations spent an estimated \$469.5 million (71 percent of the total). Lee County's lodging industry experienced year-over-year increases in the average occupancy rate of 8.6 percent and a 5 percent increase in the average daily rate for the season, producing significant growth of 14 percent in revenue per available room (RevPAR).

Preliminary December tax breaks another record

The preliminary resort tax collected for December 2015 was \$3,124,516, an 8.3 percent increase over December 2014 preliminary collections of \$2,883,737. Fiscal year-over-year collections increased 11.4 percent, with a total of \$7,282,135.

Airport news

During December 2015, 835,359 passengers traveled through Southwest Florida International Airport (RSW), an increase of 9.2 percent compared to December 2014. The passenger traffic during 2015 was a historic best for the airport with 8,371,801 travelers.

Lee County Visitation Gains

Marcia Wood, DPA, reported key 2015 calendar year growth. Those gains included more than 3 million guests in paid accommodations, 4.9 million total visitors to Lee County with international visitors representing 26 percent.

A Positive 2015 in the Hotel Industry

Carter Wilson, STR Analytics director, presented an overview of the local and national hotel industry. For 2015, Lee County led the competitive set in RevPar increase and year-over-year occupancy growth. The STR report forecast for 2016 represents positive increases locally of 5.9 percent in ADR and 7.2 percent in RevPar. The percent of change nationally is less favorable with 4.4 percent ADR and 5 percent RevPar.

New Business

The Tourist Development Council (TDC) made a legislative finding to recommend allowing the Town of Fort Myers Beach to use previously awarded beach park maintenance funding for landscaping and interpretive signage at a parking area for the Mound House. The TDC also voted to support The Sidney & Berne Davis Art Center rooftop sculpture garden project. Both funding requests will now go to the Board of County Commissioners.

Marketing Request

After a brief discussion about February bookings, the TDC made a motion to support a digital marketing campaign to combat current challenges. A request was made to have the VCB staff and county administration to activate a strategy.

The TDC will not meet in March.
