#### **Bed Tax Collection**

The preliminary resort tax collected for October 2019 was \$2,086,449, a 19.7% increase over October 2018 preliminary collections of \$1,743,173. Fiscal year-to-date preliminary tourist tax collections are \$2,147,309, an increase of 17.96% year-over-year.

#### **Airport News**

During October 2019, 638,922 passengers traveled through Southwest Florida International Airport (RSW), an increase of 12.2 percent compared to October 2018. Year-to-date, passenger traffic is up 8.8 percent from the same period last year.

## **Marketing Report**

Brian Ososky, VCB marketing director, reviewed high-level marketing strategies, including an overview of integrated packages, social media initiatives, and website projects for 2019-20. He also presented a list of new domestic target markets, a brief media mix breakdown, and a video from this year's VISIT FLORIDA Flagler Awards where the VCB earned four prestigious Henry Awards for excellence in tourism marketing. Clayton Reid, MMGY Global, presented an overview of travel trends and insights, as well as opportunities for the upcoming year.

#### **Sports Development Report**

Jeff Mielke, Lee County Sports Development director, reported that between June and September, 61,158 room nights were sold, with direct visitor spending of more than \$26 million.

### **Accessible Tourism**

Judi Durant and Joshua Lambert, VCB, and Kevin Berry, ADA Advisory Council of Southwest Florida, presented an overview on what accessible tourism is, the importance of training in inclusive spaces and a look at other destinations who are leading the industry on accessibility.
