Fall 2014 Statistics

During the fall of 2014, The Beaches of Fort Myers & Sanibel hosted more than one million visitors who spent an estimated \$627 million. Visitors staying in paid accommodations spent an estimated \$426 million. Lee County's lodging industry experienced increases in average occupancy rate and average daily rate for the fall season year-over-year. As a result, revenue per available room increased as well. International visitation increased almost 38 percent.

Preliminary December bed tax breaks another record

The preliminary resort tax collected for December 2014 was \$2,883,737 a 19.4 percent increase over December 2013 preliminary collections of \$2,414,494. Year-to-date collections are 16.1 percent ahead of last year.

Airport news

During December 2014, 765,288 passengers traveled through Southwest Florida International Airport (RSW) in Fort Myers. Figures represent a year-to-date increase in passenger traffic of four percent over the same period last year.

Record breaking gains

Marcia Wood, DPA, reported key 2014 calendar year gains. Those gains included a record-breaking 3 million in paid accommodations, five million total visitors to Lee County with international visitors making almost a quarter percent. Hoteliers remain optimistic about 2015 season.

Strategic Plan update

Pamela Johnson, VCB, reported that the bureau remains committed to the imperatives identified in the 2013-2016 strategic plan. She presented the status of key efforts.

Lee County gets boost from Sports

Jeff Mielke, Lee County Sports Development, reported on his most successful year with a total of 159,530 room nights – a 12 percent increase over last year. This included a record 113 sporting events. He thanked Lee County Parks & Recreation team members for their part in their overall success.

Budget approval

The TDC unanimously approved a \$1.4 million budget increase for global promotions and extended efforts in key markets.
