

# Report to the Industry

February 9, 2017

## Fall 2016 Statistics

During the fall of 2016, The Beaches of Fort Myers & Sanibel hosted more than 1.1 million visitors who spent an estimated \$656 million while visiting – a one percent drop in spending year-over-year. Visitors staying in paid accommodations spent an estimated \$477 million (73 percent of the total). Lee County's lodging industry experienced a year-over-year decrease in average occupancy rate and small decrease in average daily rate for the season, translating to a slight drop in revenue per available room (RevPAR).

## **Bed tax collection**

The preliminary resort tax collected for December 2016 was \$3,314,913, a 0.3 percent increase over December 2015 preliminary collections of \$3,124,516. Fiscal year-to-date preliminary tourist tax collections are \$7,386,764 an increase of 1.4 percent year-over-year.

## **Airport News**

During December 2016, 840,501 passengers traveled through Southwest Florida International Airport (RSW). Figures represent an increase of 0.6 percent compared to December 2015. Year-to-date, passenger traffic is up 2.8 percent from the same period last year.

#### **Lee County Visitation Update**

Bob Domine, DPA, reported on the fall season and 2016 highlights. Visitation among 2016 visitors staying in paid accommodations held steady while expenditures increased to its highest level exceeding \$3 billion. About one-quarter of those guests were from international markets with Germany representing the largest share.

# A 2016 review of the Hotel Industry

Ali Hoyt, STR, presented an overview of the Lee County hotel industry. While room demand and occupancy dipped slightly, both ADR and RevPAR increased in 2016. The industry is still at record-setting levels, but growth is slowing. For 2017 STR projects Lee County's average occupancy will decrease 0.5% to 69.3%, ADR will increase 2.8 to \$153.68 and RevPar will be up 2.3% at \$106.46.

#### **VCB Departmental Reports**

Marketing showcased two videos produced by Matador Network, which have already reached 90,000 views on the VCB Facebook page. The videos have been translated into German and Spanish and shared on social channels. Industry partners can imbed them in their social media platforms as well. Sports Development reported 157,000 room nights sold with direct visitor spending of more than \$67 million in 2016.
