Summer 2014 Statistics

During summer (July, August, September) 2014, The Beaches of Fort Myers & Sanibel hosted about 1.1 million visitors who spent an estimated \$479 million while visiting – a modest increase over the prior year. Visitors staying in paid accommodations spent an estimated \$309 million (65 percent of the total). Lee County's lodging industry experienced year-over-year increases in average occupancy rate and average daily rate for the season, producing growth in revenue per available room (RevPAR).

VCB breaks tax collection record for fourth consecutive year

The Lee County Visitor & Convention Bureau (VCB), representing The Beaches of Fort Myers & Sanibel in southwest Florida, today reported record-breaking tax collections for the fourth year in a row, with \$33.3 million in tourist tax on paid accommodations for fiscal year 2013-2014, which ended Sept. 30. The new record is a 16.5 percent increase over last year's record-breaking \$28.6 million in collections.

Lee County hoteliers qualify for Florida Superior Small Lodging designation

Representatives of the Florida Superior Small Lodging Association (SSL) recently announced 16 Lee County hoteliers have successfully qualified for the distinguished SSL designation. The SSL certification is a statewide hospitality recognition program. In addition, 15 of the 16 total SSL properties inspected by the Property Review Program (PRP) qualified to receive the coveted Donal A. Dermody White Glove Award for best practices in housekeeping. Properties must receive a score of 100 percent for all components of the housekeeping inspection to be eligible to receive the White Glove Award.

Lee County's newest certified Guest Service professionals honored

The Lee County Visitor & Convention Bureau (VCB) has reached the milestone of certifying its 100th Certified Guest Service Professional (CGSP®) as part of its goal to become the nation's first Certified Guest Service Destination – and the friendliest destination in the country. Kaiser Hospitality Program also certified five students for the first time.
