## **Bed tax collection**

The preliminary resort tax collected for July 2016 was \$2,718,942 a 12.2 percent increase over July 2015 preliminary collections of \$2,422,538. Fiscal year-to-date preliminary tourist tax collections are \$36,332,770, an increase of 5.6 percent year-over-year.

## **Airport news**

During July 2016, 484,074 passengers traveled through Southwest Florida International Airport (RSW). Figures represent a decrease of 1.6 percent in passenger traffic compared to July 2015. Year-to-date, passenger traffic is up 4.5 percent from the same period last year.
