

Report to the Industry August 10, 2017

Spring 2017 Statistics

During the spring of 2017, The Beaches of Fort Myers & Sanibel hosted about 1.33 million visitors who spent an estimated \$728 million while visiting – a three percent increase in spending year-over-year. Expenditures among paid accommodations guests amounted to \$500 million (69% of the total). The Lee County lodging industry saw average occupancy rates relatively equal to last spring, with an increase in average daily rates, leading to an overall increase in revenue per available room (RevPAR).

Bed tax collection

The preliminary resort tax collected for June 2017 was \$2,638,772, a 3.2 percent increase over June 2016 preliminary collections of \$2,557,534. Fiscal year-to-date preliminary tourist tax collections are \$33,480,460, a decrease of 0.2 percent year-over-year.

Airport news

During June 2017, 528,383 passengers traveled through Southwest Florida International Airport (RSW). Figures represent an increase of 7.3 percent in passenger traffic compared to June 2015. Year-to-date, passenger traffic is up 2 percent from the same period last year.

Arts & Economic Prosperity Study Update

Lydia Black, executive director, Alliance for the Arts, gave a special presentation on the positive economic impact of arts and culture in Lee County. She noted the arts and culture industry generates more than \$140 million annually and supports 3,875 full-time equivalent jobs.

New Business

The Tourist Development Council (TDC) approved \$400,000 in Attractions Marketing Funding for FY 2017-18. The TDC also unanimously approved the VCB third-quarter budget report.
